Meet the newest O'Brien Fellows

Barret L. Kurylyk

Barret grew up on the north shore of

Prince Edward Island and attended UPEI before completing his undergraduate degree in Civil Engineering at UNB, where he received the Lieutenant Governor's Silver Medal for highest graduating average in the Engineering Faculty. His research interests were sparked by summer employment in the Construction Engineering and Management research

group at UNB.

In 2009, he enrolled in the Master's

program in Civil Engineering

and a year later transferred into the accelerated PhD program.

Barret's PhD research involves simulating the projected impacts of climate change on groundwater temperature and flow rates and investigating the vulnerability of ground-

water-sourced Atlantic salmon and brook trout habitat in the Miramichi region. He is also interested in the numerical modeling of groundwater in permafrost systems and examining how they respond to climatic change. His research has been supported by the NSERC and other awards, including the Alexander Graham Bell Canada Graduate Scholarship.

Barret enjoys spending summertime outdoors, learning everything he can about earth sciences. He plans to make a career in New Brunswick looking at ways to sustainably develop local resources while protecting the province's aquifers and rivers.

Between 1975 and 2012, the Foundation received over 2,169 applications and granted 280 fellowships, including 58 renewals.

The total value of the awards granted in these years was \$1,382,000.

Michel Thibodeau

Michel hails from Tabusintac, a bilingual community in northeastern New Brunswick. His interest in human behaviour began at C.S.C. La Fontaine, a francophone community high school in nearby Neguac, and eventually led him to the University of New Brunswick in Fredericton, where he received his B.A. (Honours) in Psychology in 2009.

Michel earned his M.A. in Clinical Psychology at the University of Regina, Saskatchewan, with the support of a Canadian Institutes of Health Research (CIHR) Master's award that allowed him to focus on his research interests in anxiety-related mental disorders and chronic pain. Immediately after completing his M.A. in 2011, he began his Ph.D. in Clinical Psychology at the University of Regina with a further doctoral award from the CIHR.

Michel's dissertation will explore the nature of predispositions that may underlie anxiety-related mental disorders. Upon completion of his Ph.D., he hopes to work as a clinical psychologist, therapist, and professor of psychology.

Michel's broader goal is to have a



positive impact on the health of Canadians by informing the treatment of mental disorders through clinically -oriented research.

Laura McFarlane Tranquilla

Laura grew up first in Dalhousie and later in Boiestown, New Brunswick. Her research interests in avian ecology and conservation began during her BSc program at the University of New Brunswick, which involved studying songbird territories in the province's blackfly -infested forests and also, fortunately, seabird colonies in the Bay of Fundy. Captivated by the lives of seabirds such as puffins and stormpetrels, she has since done field research on remote coastlines and islands of Canada's east and west coasts. For Laura, no place beats a seabird colony for testing scientific

hypotheses.

After completing her MSc at Simon Fraser University (B.C.) with a specialty in the breeding physiology of seabirds, Laura worked as a research associate and consultant. Her work's unremitting schedule and pure joy of accom-

plishment was remarkably relevant training for parenthood, she discovered. In 2008, as a mother of two children, Laura became a PhD



candidate at Memorial University (NL), where she studies Atlantic seabirds' use of the marine habitat during winter. Her collaborative and work experiences to date have resulted in over 30 publications and dozens of presentations. Laura is enthusiastically supported in all

things by her husband Jim and two young children.

Terri Croft of Riverview, NB, holds a Bachelor of Music in Performance from Dalhousie University and is currently pursuing a Master's degree in Performance at the Cleveland Institute of Music. Starting with music lessons at age four, Terri quickly established herself as a prodigious

talent in fiddling when she became a three-time winner of the Canadian Open Fiddle Contest (12 and under category) and won the first of four



Maritime Open Class Fiddle Championships (all ages) by the age of 13. Almost a decade later, she still holds the record for both contests

Terri's focus shifted in her mid-teens toward classical

violin repertory. She is now a sixtime NB Provincial Music Festival winner who has earned national awards and accolades. As a chamber musician, she has performed in concert series throughout the Maritimes and with several orchestras and chamber ensembles. In 2011, her "Trio Benterria" won the chamber music category at the National Music Festival. Terri has served as concertmaster of several orchestras, completed an apprenticeship with Symphony Nova Scotia, and has volunteered her musical gifts to seniors' residences, hospitals, fundraisers, and the Cleveland School of the Arts.

This year's Selection Committee

The Selection Committee, which is responsible for ranking and recommending candidates for awards, has seen its workload increase substantially in recent years because of the growing number of applicants for O'Brien Foundation fellowships.

The Committee welcomed four new

members between 2011 and 2012: Dr. Christl Verduyn (Director, Centre for Canadian Studies at Mount Allison University), Dr. Diana J. Hamilton (Associate Professor of Biology, Mount Allison University), Dr. Loretta Secco (Assistant Dean of Nursing, University of New Brunswick), and Dr. Enrico DiTomasso (Professor of Psychology, UNBSJ). They join existing Committee members Dr. Catherine Gidney (Chair) and Mr. Richard Hornsby in taking on this challenging work.

Established in 1971, The Leonard and Kathleen O'Brien Humanitarian Trust provides postgraduate fellowships for deserving students who wish to pursue advanced study or research in any academic, artistic, or professional field at any recognized university or research establishment. The fellowships are administered by a Committee known as The O'Brien Foundation.

The Honourable J. Leonard O'Brien was a life-long resident of Nelson-Miramichi who made distinguished contributions to the forest industry and the public service of New Brunswick. Mr. O'Brien was a lumber merchant, Speaker of the Legislative Assembly, 1925-1930, Member of Parliament 1940-45, and Lieutenant Governor of New Brunswick, 1958-65.

Kathleen (O'Leary) O'Brien was born in Richibucto and attended Mount Saint Vincent's College in Halifax before graduating in Nursing from the Roosevelt Hospital School in New York. Her extensive charitable work was recognized by Pope Paul VI in 1963 when Mrs. O'Brien was made a Dame of Magistral Grace of the Order of Malta. She died in 1971 and Mr. O'Brien in 1973.

As a final memorial to himself and his wife, Mr. O'Brien made two bequests which reflect their deep concern for the natural resources of New Brunswick and for the

education of its people.

The first bequest was the grant of Beaubear's Island to the Crown as a national Historic Park to be preserved "in its primeval state where citizens of New Brunswick and others may relax and enjoy peace, quiet and solitude in the place where the first settlers sought the same."

The second bequest provided for the establishment of the O'Brien Foundation to grant fellowships to students, scholars, and artists wishing to pursue postgraduate study and research. O'Brien Foundation fellowships are awarded through an annual competition. In its first twenty-eight years of operation, academic years 1975-76 to 2008-09, the Foundation received over 1,950 applications and granted 259 fellowships, including 58 renewals. The total value of the awards granted in these years was \$1,224,000.

The O'Brien Foundation is a humanitarian trust, operated exclusively for educational purposes. Donations are welcome from any persons or organizations wishing to assist promising students and artists to develop their knowledge and skills through advanced study. Donations to the O'Brien Foundation qualify for tax-exempt receipts.
